

**Park County Board of County Commissioners
June 1, 2011
Special Meeting**

A special meeting of the Board of County Commissioners of Park County, Wyoming, was held on Tuesday, June 1, 2011 at 6:00 p.m. at the Grizzly Room of the Park County Library, in Cody, Wyoming. Present were Chairman Bucky Hall, Commissioners Loren Grosskopf, Dave Burke, Joe Tilden, Tim French and County Clerk Jerri Torczon.

Chairman Bucky Hall called the meeting to order and led the audience in the pledge of allegiance.

Bureau of Land Management (BLM) Draft Resource Management Plan (RMP) and Draft Environmental Impact Statement (EIS) for the Big Horn Basin.

Chairman Hall introduced Park County Commissioners and members of the Local Government Cooperating Agencies of the Big Horn Basin, including Big Horn County Commissioners, Hot Springs County Commissioners, Washakie County Commissioners, and the Cody and Meeteetse Conservation Districts. The Big Horn Basin Cooperators have hired a consulting firm, the Ecosystem Research Group from Missoula, Montana to aid cooperators with understanding the BLM's Draft Resource Management Plan and Draft Environmental Impact Statement for the Big Horn Basin, and to assist cooperators through the RMP process.

Sady Babcock, Environmental Scientist with the Ecosystem Research Group, presented a four-county review PowerPoint presentation regarding the Resource Management Plan, which illustrated different alternatives in the plan and depicted the BLM's preferred alternative. The RMP identified 571,295 acres of land with wilderness characteristics.

John Sanford, GIS Specialist with the Ecosystem Research Group, presented the Park County Review PowerPoint presentation which specifically related to BLM's Resource Management Plan for Park County.

Several members of the audience presented oral comments including Big Horn County Commissioner Keith Grant, Marvin Blakesley, Sean Sheehan, Tom Fitzsimmons, Paul Lanchbury, Matt Vezza, Hilary Eisen, Bob Whisonaunt, Warren Murphy, Betty Dominick, Marshall Dominick, Randi Weaver, Mark Maslak, Jim Hillberry, Lou Cicco and Nathan Maxon.

The deadline for comments is July 20, 2011 and Park County Commissioners requested that the public submit specific comments either by way of mail, on-line or e-mail.
