

**Park County Board of County Commissioners  
Regular Meeting  
May 21, 2013**

A regular meeting of the Board of County Commissioners of Park County, Wyoming, was held on Tuesday, May 21, 2013. Present were Chairman Loren Grosskopf, Commissioners Bucky Hall, Lee Livingston, Joe Tilden and Tim French, and County Clerk Jerri Torczon.

Chairman Loren Grosskopf called the meeting to order and County Assessor Pat Meyer led the audience in the Pledge of Allegiance.

**Convene as County Board of Equalization.**

Chairman Grosskopf convened the meeting as the County Board of Equalization. County Assessor Pat Meyer and Bryan Henderson, Chief Appraiser/Analyst, reported that the Assessor's Office has received two tax protests, one from Fred Reynolds and one from WalMart. After a general discussion, it was the consensus of the Board to hear the protested cases on July 17, 2013 at 8:30 a.m. and at 10:15; to appoint Southgate "Sox" Freeman, III as the Hearing Examiner; and to designate Carol Gureski, Owner of CG Virtual Services, as the Court Reporter.

It was moved by Commissioner French, seconded by Commissioner Tilden and unanimously carried to adjourn as the County Board of Equalization. The meeting returned to regular form.

**Wolf Litigation Update.**

Commissioner Joe Tilden presented an update on the Wolf Litigation cases. He reported that the plaintiff in the Wyoming case has filed a petition for voluntary dismissal. The State of Wyoming has filed a motion to set aside the Notice of Dismissal, as the State wishes to keep the case active in Wyoming, while two cases are pending in Washington D.C. Commissioner Tilden reported that the maximum increased cost to the County would be approximately \$3,000.00 for continued participation in the litigation. Following a general discussion, it was the consensus of the Board to stay the course.

**Viewer's Report for the Vacation of a Portion of County Road 49b.**

County Engineer Greg Meinecke presented the Viewer's Report for the Vacation of a Portion of County Road 49b. County Road 49b (Lane 14) was established in 1928-29. In 1983, a different route was adopted, with an alternate easement, with portions to be vacated. The vacation was never finalized and with the new Willwood Bridge being built, he recommended that the vacation proceed. The survey has been completed by the Wyoming Department of Transportation. It was moved by Commissioner Hall, seconded by Commissioner French and unanimously carried to accept the Viewer's Report and to proceed with the recommendation of vacating a portion of County Road 49b.

**Executive Session.**

It was moved by Commissioner Livingston, seconded by Commissioner Tilden and unanimously carried to go into Executive Session regarding personnel matters, pursuant to Wyoming Statute §16-4-405(a)(ii).

It was moved by Commissioner Hall, seconded by Commissioner Livingston and unanimously carried to go out of Executive Session.

**Property Committee Recommendations.**

County Assessor Pat Meyer presented the Property Committee Recommendations for selling County properties. Some of the properties will need to be surveyed and/or a title search completed. After receiving legal advice, the Kysar Landfill will not be sold. The committee will meet again and come back to the Board with more details.

**Approval - Resolution for Establishment of a Local Court Security Management Committee.**

County Attorney Bryan Skoric came before the Board regarding the establishment of a Local Court Security Management Committee. The committee is to meet twice a year and would make recommendations to the State. It was the consensus of the Board to appoint Judge Bruce Waters, Judge Steven Cranfill, County Attorney Bryan Skoric, Sheriff Scott Steward and all members of the Board to the committee. A tentative date for the committee to meet was established for June 18, 2013 at 3:30 p.m. It was moved by Commissioner Tilden, seconded by Commissioner Livingston and unanimously carried to approve **RESOLUTION NO. 2013-21, ESTABLISHING A COURT SECURITY COMMITTEE, PURSUANT TO THE WYOMING COURT SECURITY ACT, WYOMING STATUTE §5-11-101(e)**, to be signed at a later date after review by the County Attorney.

**Approval of Vouchers.**

Vouchers were presented to the Board for their consideration. It was moved by Commissioner Tilden, seconded by Commissioner Livingston and unanimously carried to approve the following vouchers for payment:

**Approval of Minutes.**

The minutes of the regular meeting of May 14, 2013 were presented to the Board for their consideration. It was moved by Commissioner Livingston, seconded by Commissioner Tilden and unanimously carried to approve the minutes as presented.

**Approval of Payroll.**

Payroll for May 9, 2013, in the amount of \$355,127.92 and \$267.96 and for May 17, 2013 in the amount of \$27.36 were presented to the Board for consideration. It was moved by Commissioner Tilden, seconded by Commissioner Livingston and unanimously carried to approve payroll as presented.

**Approval - Directive Letter to County Treasurer.**

A directive to transfer \$100,000.00 from the County Road Fund to the County General Fund was brought before the Board for consideration. It was moved by Commissioner Tilden, seconded by Commissioner Hall and unanimously carried to have staff write the directive letter for the Board's signature.

**Approval - Letter of Support for Wyoming Primary Care Support Grant.**

The letter of support for the Wyoming Primary Care Support Grant for Powell Health Care Coalition to open a Community Health Center in Powell was presented to the Board for consideration. It was moved by Commissioner Livingston, seconded by Commissioner Hall and unanimously carried to approve the letter as presented.

**Approval - Grant Draft Request #4 to State Loan & Investment Board/Fairgrounds Electrical & Infrastructure Upgrade (MRG-11245 Pa).**

Teecee Barrett, Deputy Clerk, came before the Board and presented the Grant Draft Request #4 to the State Loan & Investment Board for the Fairgrounds Electrical & Infrastructure Upgrade (MRG-11245 Pa), in the amount of \$59,781.50. It was moved by Commissioner Hall, seconded by Commissioner Livingston and

unanimously carried to approve the request as presented, and authorized the Chairman to sign.

**Approval - Schedule for Upcoming County Board Appointments.**

Whitney Koontz, Office Assistant, came before the Board and presented a proposed schedule for upcoming appointments to the Park County Library Board and the Park County Museum Board. Members whose terms expire include Tanya Lowham on the Library Board, and Astrid Northrup and Linda Orrell on the Museum Board. It was moved by Commissioner French, seconded by Commissioner Tilden and unanimously carried to approve the schedule as presented with advertisement dates in the Cody Enterprise on May 27th and June 3rd, in the Powell Tribune on May 28th and June 4th, and in the Meeteetse Community Bulletin during the weeks of May 27th and June 3rd. The deadline for applications will be June 6, 2013 at 3:00 p.m. with interviews on June 11th or June 18th.

**Bid Award - Powell Search & Rescue Building.**

Deputy County Attorney James F. Davis came before the Board and recommended that the high bidder of Dale & Nancy Robison be awarded the bid for the sale of the Powell Search & Rescue Building. It was moved by Commissioner Hall, seconded by Commissioner Tilden and unanimously carried to award the bid as recommended, in the amount of \$146,547.93 and to allow the Chair to sign all necessary documents at closing.

**Recess.**

The meeting recessed for lunch and reconvened at 1:15 p.m. Commissioner Grosskopf left the meeting in order to attend a meeting in Flagstaff, Arizona.

Vice-Chairman Tilden opened the public hearing on the Floodplain Permit Application of William & Barbara Kneer to place fill for bank stabilization in the Southfork of the Shoshone River. The proposed project is located at 9 Josie Lane in Tract 55, T 50N R104 W, Park County, Wyoming. County Planner Linda Gillett presented the staff report and answered questions of the Board. Comments were received from William Kneer regarding material to be used in the future to stabilize the bank. It was moved by Commissioner Livingston, seconded by Commissioner Hall and unanimously carried to close the public hearing.

Becky Ross, Planner II, presented the staff report and answered questions of the Board. Comments were received from the applicant and Steve Follweiler of Holm, Blough & Co. regarding the existing water well. It was moved by Commissioner Hall, seconded by Commissioner Livingston and unanimously carried to close the public hearing.

**Public Health Monthly Update.**

Bill Crampton, Public Health Nurse Manager, came before the Board and presented the Public Health monthly update. Mr. Crampton stated that they had several clinics for 6th grade shots and had an increase in students getting their immunizations for school. He stated that Public Health will be expanding their services in minor ways to address potential gaps in communicable disease coverage.

**Approval - Stop-Loss Health Insurance Renewal.**

Eric Deeg, Health Insurance Consultant, appeared telephonically regarding the Park County Employee Stop-Loss Insurance Renewal with Companion Life Insurance Company. He reported that the County's self-funded employee health plan has done very well this past year. After a general discussion, it was moved by Commissioner Hall, seconded by Commissioner Livingston and unanimously carried to approve the renewal for Stop-Loss Health Insurance at the \$60,000.00 level
