

**Park County Board of County Commissioners
Regular Meeting
June 14, 2016**

Chairman French called to order a regular meeting of the Board of County Commissioners of Park County, Wyoming, on Tuesday, June 14, 2016. Present were Chairman Tim French, Vice Chairman Lee Livingston, Commissioners Loren Grosskopf, Bucky Hall, Joe Tilden, and Deputy County Clerk Teecee Barrett.

Commissioner Livingston led the audience in the Pledge of Allegiance.

Approve-State Lands and Investment Board Agreements.

Colleen Renner, County Clerk, presented the award agreements from the State Lands and Investment Board for signature from Chairman French. Commissioner Grosskopf requested a breakdown of the current projects with a balance of remaining unallocated funds. Commissioner Livingston moved to approve the contracts and allow the Chairman to sign, seconded by Commissioner Tilden and unanimously carried.

Approve-Park County Revised Application for Temporary Assistance for Needy Families (TANF) FFY 17.

Shaunna Romero, Executive Assistant, presented the revised application to the Board for approval. The total award amount will be \$72,764.00. Commissioner Tilden moved to approve the application, seconded by Commissioner Hall and unanimously carried.

Approve-Letter to Forest Service Requesting Extension.

Commissioner Grosskopf suggested that the Board write a letter to the Forest Service requesting a comment period extension for the management program which includes 90 different changes with a comment due date of June 25, 2016. Commissioner Hall suggested that the Board hold a work session the second week of July to compile comments on the suggested changes. Commissioner Grosskopf moved to write a letter to the Forest Service dated June 14, 2016, requesting an extension on the comment period, seconded by Commissioner Livingston and unanimously carried.

Approve-Events Department Seasonal Employee Wages.

Echo Renner, Events Coordinator, came before the Board with an updated wage schedule for the seasonal Events Department employees. Previously the Board gave her a pay range that she could use and from those instructions she created a scale based on years of experience. The Clerk's office has completed new employees' paperwork, pending the approved pay scale to complete the files. The new pay scale will be implemented into the Park County Pay Policy with official action from the Board in the form of a resolution. All provisional and temporary Events employees will be hired within the scale's position title and pay range. Commissioner Hall moved to approve the proposed pay scale for the seasonal temporary Events Department employees, seconded by Commissioner Livingston and unanimously carried. The resolution will be considered for approval at the June 21 meeting.
