## AGENDA TOPICS

Welcome & Overview | Commissioner Hall

Commissioner Hall provided background related to the Park County Commissioners' decision to participate in the Wyoming Public Lands Initiative (WPLI). Commissioner Hall will serve as the chairperson of the WPLI Advisory Committee with Commissioner Lee Livingston serving as the co-chairperson. Hall said he would like to see a conclusive decision for the WSAs.

Introductions | Committee Members, Attendees

The committee members and other meeting attendees provided their names and WPLI positions, roles in the community, what contributions each hopes to make and desired take-aways.

Considerations for the WPLI Process | Tara Kuipers

Facilitator Tara Kuipers provided an overview of the WPLI purpose, process, products and outcomes (contained in detail in the Park County WPLI Advisory Committee Group Charter): The Park County Board of Commissioners appointed the WPLI Advisory Committee to conduct a collaborative review process of the WSAs and other potential land use interests of the two Wilderness Study Areas (WSAs) located in Park County: the High Lakes WSA and the McCullough Peaks WSA. Once developed, the WPLI Advisory Committee will submit a proposed WSA management recommendation for the WSAs to the Board of County Commissioners for approval. Once approved, the Wyoming County Commissioners Association, in cooperation with the office of the Governor and the offices of the Wyoming federal delegation, will review the Advisory Committee recommendations and to the maximum extent practicable, include them in a legislative draft to be introduced in Congress.

The 5-step collaborative problem solving process model was explained (available at <a href="http://wyo-wcca.org/~wcca/index.php/initiatives/wpli/additional-resources/">http://wyo-wcca.org/~wcca/index.php/initiatives/wpli/additional-resources/</a>).

Expectations of Advisory Committee members and Alternate members were discussed and defined (contained in detail in the Park County WPLI Advisory Committee Group Charter). All appointed members are encouraged to attend and participate in all Advisory Committee meetings and functions.

Responsibilities of Committee members include: Acting with transparency and in good faith; keeping constituents and interest groups informed; attending meetings; being prepared; understanding and abiding by the charter.

The process for replacement appointments was discussed. Advisory Committee members were asked to communicate via email in advance to the advisory committee secretary if unable to attend a meeting or function.

Resource agencies (BLM, Forest Service) have offered to provide maps and other resources. Chairman Hall said the committee will invite representatives from the agencies to attend meetings, as needed. Most resources will be obtained and provided to committee members in advance.

Guidelines for interaction were established, as contained in the Park County WPLI Advisory Committee Group Charter. Email will not be utilized for discussion among committee members; discussions will take place primarily in scheduled meetings and functions.

Tara provided an overview of the Committee's decision-making process by consensus. The charter outlines the six-point consensus scale, to be discussed further by the Committee in the June 7 meeting.

The Committee welcomes public participation at all of its meetings and decided to include at the end of future meeting agendas time for public comment. A process for public comment and time limits will be implemented, as needed.

Committee members are free to speak to the media; members should make it clear to the media that they are representing themselves and not the Advisory Committee at large. The Committee Chair will serve as the formal representative of the Advisory Committee to the media.

A draft Park County WPLI Advisory Committee Group Charter will be developed by Tara and emailed to the members for their review. Areas highlighted will be discussed in the June 7 meeting.
